Due to a scheduled surgery at the end of April and an eight weeks' recovery time, LeRoy Corbin may not be able to begin his seasonal position at the cemeteries this spring. The Trustees may be looking into hiring a temporary person to do the weed eating until LeRoy can resume his normal activities.

Ed will look into the date of the Triad Community Service Day. The Township could possibly get a group of students together to help with raking at the cemetery.

The next township meeting will be held on Monday, March 18, 2024 at 7:00 PM.

Being no further business, Andy made a motion to adjourn, seconded by Ed.
