The fiscal officer reported that she had to stop payment on 500 checks that she recently ordered because they were lost by UPS. New checks were ordered and received in two days. The fiscal officer explained a service that Park National Bank offers that is called Positive Pay and ACH Debit Block. These services would protect the township against being a target of payment fraud attempts. After some discussion, no decision was made.

The fiscal officer reported that the township has received a new computer and printer through the State of Ohio. All of the hardware from the present computer needs to be transferred to the new computer within 60 days. The fiscal officer stated that she will need some assistance with this transfer. Cinda made a motion to allow up to \$250.00 to reimburse someone to help with this transfer. Ed seconded the motion. Roll call was taken. All in favor. Motion passed.
