Jane Napier, Champaign County Assistant Prosecutor, spoke to the Trustees about the proposed 40 megawatt solar farm that is being planned on McCarty Road. A special Zoning Commission meeting will be held at 6:00 PM on Wednesday, March 16, 2022 at the Municipal Building in Woodstock. The Commission will be reviewing a model zoning text for solar energy systems in Rush Township.

Old Business:

The fiscal officer reported to the Trustees that the recent application for tax exemption status on the property at 10624 Urbana Woodstock Pike has been approved.

The Township has received \$167.28 in redistributed unclaimed funds from the American Rescue Plan Act.

New Business:


Road work (2.1 miles) from Urbana Woodstock to the Township line on McMahill Road was discussed. This will include widening the road and pug mix to be applied. The Champaign County Engineer's office will be working on this project with an estimated cost of \$333,000.00. More detailed estimates will be sent to the Township at a later date. Andy made a motion to accept the project, seconded by Cinda. Roll call was taken. All in favor. Motion passed.
