New Business:

Andy made a motion to hire Susie Finley on a part time basis to mow the cemeteries at a rate of \$12.00 an hour until Leroy returns. Ed seconded the motion. Roll call was taken with the following results: Ed – yes; Andy-yes; Cinda-abstain. Motion passed with a majority of the vote.

The Trustees will hold a public hearing concerning proposed amendments to the Rush Township Zoning Resolution on Wednesday, June 29, 2022 at 6:00 PM at the Woodstock Municipal Building.

The fiscal officer passed out a work copy of the 2023 Budget to the Trustees to read through before the next meeting. A budget hearing will be held at 7:00 PM on July 4, 2022 with the regular township meeting to follow. The budget is due to the Champaign County Auditor by July 20, 2022.
