Tim Kemper presented the Trustees with the zoning text amendments that were approved at the May 23, 2022 zoning board meeting. The Trustees have set up a public meeting concerning the proposed amendments to the Rush Township Zoning Resolution for June 29, 2022 at 6:00PM at the Woodstock Municipal Building. Jane Napier, Assistant County Prosecutor, reminded the Trustees that a notice will need to be published in the newspaper ten days before the meeting.

Old Business:

Andy reported that the roof of the mausoleum at Woodstock Cemetery has been removed. A new roof will be in place in the next few weeks.

New Business:

The Champaign County Commissioners are requesting a resolution from any Board of Township Trustees who desire to have large-scale wind and solar facilities prohibited in all or part of their township. A decision was tabled until the next Township meeting.

J. P. Hackney of Heelstone Renewable Energy told the Trustees that he has spoken to several tax assessors who said that they have not seen a decrease in property values of neighboring land bordering a wind farm. He also stated that Heelstone is reapplying their application & requesting to be determined as a public utility.

The next meeting will be held on Monday, June 20, 2022 at 7:00 PM.

Being no further business, Andy made a motion to adjourn, seconded by Cinda.
