

RUSH TOWNSHIP MINUTES

Rush Township Trustees met in regular session on Monday, February 21, 2022 at 7:00 PM at the Township Building in North Lewisburg. Present were Cinda Bailey, Ed Funderburgh and Andy Heath.

Ed Funderburgh called the meeting to order. The minutes of the meeting held on February 7, 2022 were approved as read.

Andy moved to pay the bills, Cinda seconded. All in favor. Fiscal officer instructed to issue warrants for the same.

There was no correspondence.

Old Business:

Cinda reported that she has received notice from the ODOD Building Demolition program that one of our sites that was submitted met all the requirements and she is confident that this site will be part of the project.

The resolution for the authorizing of expenditures from the American Rescue Plan Act Funds was tabled pending further info from the Ohio Township Association.

New Business:

Andy made a motion to reallocate \$15.30 from the Cemetery tax collection fees account #2041-410-314-0000 to the Cemetery O.P.E.R.S. account #2041-410-211-0000. Cinda seconded the motion. Roll call was taken. All in favor. Motion passed.

After some discussion to increase the current pricing of fees for both cemeteries due to increase in expenses, Andy made the following motion: Opening/closing weekday fees will be increased from \$350 to \$500. Opening/closing Saturday fees will be increased from \$550 to \$750.00. Infant burial will now be clarified as a Stillborn burial and the price will remain at \$200. There will be no burials on Sundays or Federal Holidays. Burial sites will be increased from \$250 to \$300 per site. Foundations will now be \$0.75 cents per square inch with a minimum of \$150. (Original cost was \$0.30 per square inch with a \$40.00 minimum.) Cinda seconded the motion. Roll call was taken. All in favor. Motion passed.

Andy made a motion to accept the 2022 Permanent Appropriations. Cinda seconded the motion. Roll call was taken. All in favor. Motion passed.

The next meeting will be held on Monday, March 7, 2022 at 7:00 PM.

Being no further business, Andy made a motion to adjourn, seconded by Cinda.
