Old Business:

Cinda made a motion to transfer \$150.00 from Cemetery small tools and minor equipment account #2041-410-430-0000 to Cemetery machinery, equipment and furniture account #2041-760-740-0000. Andy seconded the motion. Roll call was taken. All in favor. Motion passed.

Foundation orders were due April 15 with one order for Woodstock Cemetery and ten orders for Maple Grove Cemetery.

Andy made a motion to accept Resolution 01-2022-04-18 authorizing expenditure from 2021 American Rescue Plan Act Funds. Cinda seconded the motion. Roll call was taken. All in favor. Motion passed.

Andy made a motion to pay the Champaign County Engineer \$7674.98 for berm and mailbox work on McMahill Road from the Road and Bridge Fund. Cinda seconded the motion. Roll call was taken. All in favor. Motion passed.

New Business:

Andy made a motion to pay LeRoy Corbin \$12.00 per hour effective immediately for seasonal work this year in the Township's two cemeteries. Cinda seconded the motion. Roll call was taken. All in favor. Motion passed.



This will include taking down one large maple tree and grind the stump, take down one broken branch and grind out three other miscellaneous stumps in Woodstock Cemetery. In Maple Grove Cemetery he will take down seven arborvitae trees and grind out a total of ten stumps. Cinda seconded the motion. Roll call was taken. All in favor. Motion passed.
