New Business:

Brad Herron, Rush Township Zoning Inspector, reported that the solar company has applied for a conditional use permit as a public service facility. He said that he denied the request. Brad also reported that there is no fee structure set up for a conditional use application.

Andy made a motion to charge a fee of \$200.00 for a conditional use application. Cinda seconded the motion. Roll call was taken. All in favor. Motion passed.
