Rush Township Trustees met in regular session on Monday, January 20, 2025 at 7:00 PM at the Township Building in North Lewisburg. Present were Cinda K. Bailey, Ed Funderburgh and Andy Heath.

Cinda Bailey called the meeting to order and led the group in the Pledge of Allegiance.

Andy Heath made a motion to appoint Ed Funderburgh as the Chairman for 2025. Cinda Bailey seconded the motion. Roll call was taken. All in favor. Motion passed.

Cinda made a motion at 6:51 PM to move to Executive Session to discuss a personnel matter. Andy seconded the motion. At 7:02 PM Cinda made a motion to go out of Executive Session, seconded by Andy.


